#### **PRIVACY POLICY**

Riviera Investors (P) Ltd, a non-deposit-taking non-banking financial company registered with the Reserve Bank of India and having its registered office at C-902, Park View SPA, Near DPS Primary Wing, Sector 47, Gurgaon-122001, owns, manages and operates this platform under the brand name 'Riviera' (hereinafter referred as "Company", "We", "Us" or "Our").

We respect Your privacy and are committed to protecting it through Our compliance with this privacy policy. This policy describes:

- the types of information that We may collect from you when you access or use Our website(s), application(s) and other online platform(s) (collectively, Our "Platforms"); and
